#### TYPE OF DATA PROCESSED AND PURPOSE OF TREATMENT

This website offers informations about AGREX SPA products and services.. During site navigation, information regarding the customer, or more generally regarding the visitor to the site, may be acquired as follows:

Navigation data

During normal operation, the IT systems and software procedures used to run this site collect some personal data, which are implicitly transmitted through the use of Internet communication protocols.

This technical/IT data are collected and used on an aggregated and anonymous basis exclusively to improve quality of service and obtain statistics on site use.

**COOKIE POLICY** 

What is a cookie?

#### **Function**

### Indispensable "technical" cookies

They are essential for the proper functioning of the site pages. Without these cookies certain functionalities may be compromised and access to content may be restricted. # Functionality "technical" cookies

These are cookies record information about choices made by the user to improve navigation (such as language, or pre-fill a form with the name previously used). Such cookies might contain personal information (such as the user name). Without these cookies some features and navigation between pages may be affected.

#### **Performance cookies**

These are cookies used to understand: if users are new or returning, how they use the site, how they move through the pages, how long they stay on the page and on the site, what geographical areas they they come from. Data do not identify user as a person but they are aggregated anonymously by the analysis tools. The deactivation does not compromise the features offered by the site in any way.

#### Social share cookies

Some widgets provided by social networks (Facebook, Twitter, YouTube, Google Maps, etc.) can use their third-party cookies. The deactivation does not compromise the use of the site, except those sections in which widget can be installed (eg integration of video or maps) and in some cases the possibility of rapid sharing of content or the opportunity to comment some areas of the site.

#### **Publicity cookies**
